(b) Second Phase - The Final

You can vote for ONE to TWO (1-2) of your favorite contestants to be among the top THREE (3) winners out of the TEN (10) finalists.

You may re-submit your vote for unlimited times before the voting period ends, but all your previous submissions will not be accumulated and every submission will be counted as ONE (1) independent vote. Only your last submission will be recorded as valid vote.

3. Lucky Draw & Prize

(a) First Phase -The Semi-final

- i. Each entrant who has successfully participated the first phase of Voting will be given ONE (1) chance to win the first lucky draw. Re-submission of votes will not give you additional chances to win.
