

1. 前言

- (A) 2023香港小姐競選(以下簡稱「競選」)由電視廣播有限公司 (以下簡稱「TVB」或「大會」)舉辦。任何女性若符合下述條件者均可參加(以下簡稱「參選者」)。競選以準決賽及/或決賽進行,勝出者可能被TVB提名參加國際性選美盛會。
- (B) TVB有權自行決定製作與競選有關之電視節目及以任何形式發佈 ,並擁有有關節目之所有權利。
- (C) 本報名表格可分別由參選者或提名人按第4段之參選程序填寫。若本報名表格由參選者填寫,則必須要由參選者及提名人簽署(如參選者尚未滿十八歲,必須由家長或監護人代為簽署)。若本報名表格由提名人填寫,則由提名人簽署便可;不用參選者簽署。
- (D) TVB保留一切有關競選安排與報名表格條款及細則之最終闡釋及 決定權。

2. 參加資格

參選者必須具備下列條件,以符合參選資格:

- (A) 參選者必須為女性;
- (B) 參選者必須於二○二三年八月一日已年滿十七歲及二○二四年 二月二十九日尚未滿二十八歲(以西曆計算);
- (C) 參選者必須持有有效之香港身份證及護照;
- (D) 參選者必須由一位提名人提名,而該提名人必須符合第3段所列之條件;
- (E) 參選者必須不受任何合約束縛,以致不能簽署及履行第6段所述 之合約;
- (F) 參選者不得為TVB或其集團公司的僱員;
- (G)參選者必須從未經歷任何不論有效或經已無效之婚姻儀式,而該項婚姻儀式不論其屬公證、宗教、習俗或部族,於世界任何地方被承認為一項婚姻儀式者;及
- (H) 參選者必須從未懷孕;

根據參選者提供的情況及背景,TVB有絕對權決定豁免及/或放寬上 述任何條件。

3. 提名人

參選者必須由個人(非公司)提名,並歡迎全港藝人提名。 提名人必須具備下列條件,以符合提名資格:

- (A) 提名人必須在簽署本報名表格當日已親身認識參選者。
- (B) 提名人必須在簽署本報名表格當日年滿十八歲(以西曆計算)。
- (C) 提名人必須持有有效之香港身份證或護照。
- (D) 如TVB要求,提名人須親身出席香港小姐競選大會及有關之電視節目;
- (E) 每位提名人可提名多於一位參選者;及
- (F) 提名人不得為TVB或其集團公司的僱員(藝人除外)。

4. 參選程序

- (A) 如填寫本報名表格者為參選者,必須:
 - (i) 填妥「參選者資料」並簽署;
 - (ii) 填妥「提名人資料」並由提名人簽署;
 - (iii) 填妥家長或監護人的資料(如參選者尚未滿十八歲); 及
 - (iv)於遞交已根據上述條文填妥之報名表格時,必須連同下列文件
 - 甲. 參選者之身份證及護照副本;及
 - 乙. 參選者之近照(必須於提交日期前三個月或以內拍攝)兩張 (一張半身,一張全身)。
- (B) 如填寫本報名表格者為提名人,必須:
 - (i) 填妥「參選者資料」註明 ## 的部份,其他資料如能提供亦可填寫;
 - (ii) 填妥「提名人資料」並簽署;及
 - (iii) 於遞交已根據上述條文填妥之報名表格時,必須連同參選者之 近照(必須於提交日期前三個月或以內拍攝)。

5. 甄選

- (A) TVB收妥所有報名表格後,將從所有參選者中邀請部份參選者接受由TVB於指定時間及地點進行之甄選。甄選標準及形式由TVB決定,甄選過程可能會被攝製成電視節目及以任何形式發佈。
- (B) TVB將從甄選中選出部份參選者參加準決賽及/或決賽。
- (C)被邀請參加甄選的參選者將獲TVB通知。海外的參選者必須於 收到TVB通知後在指定時間內回港接受甄選。如該參選者獲選 進入準決賽及/或決賽,TVB將贊助參選者由其居住地方至香 港的來回機票一張(經濟客位)之費用。參選者必須出示有關 文件證實其到港日期在以上所註明的甄選期內及有效機票付費 收據,方可獲得贊助。

6. 合約

參選者必須另行簽署TVB所訂定之合約,方得進入準決賽及/或決賽。

7. 同意聲明

- (A) 參選者明白及同意TVB有權隨時:
 - (i) 要求參選者出示居留證明文件;
 - (ii)接納香港以外其他地區之身份證或護照;
 - (iii) 廢除參選者之參選資格而毋須作任何解釋;及
 - (iv)取消甄選及/或準決賽及/或決賽或更改其之舉辦日期。
- (B) 參選者保證她已獲得第4(A)及/或4(B)段提交照片之相關權利並授權TVB以任何形式及方式使用該等照片。參選者並同意一經提交,該等照片即屬TVB所有,TVB不用發還參選者該等照片。同時,除根據重要事項C(i)項之約定外,參選者將不可索回第4(A)及/或4(B)段所述之文件副本及所有材料。

8. 保證

9. 文字

本報名表格分別以中、英文兩種語言擬定。參選者明白本報名 表格的中文版本只作參考用;若兩個版本內容有參差之處,則以 英文版本為準。

10. 法律

本報名表格所列之一切條件及章則皆以香港特別行政區法律為依歸。

1. INTRODUCTION

- (A) Miss Hong Kong Pageant 2023 ("the Contest") is organized by Television Broadcasts Limited ("TVB"). It is open to females who satisfy the requirements set out below ("the Contestant"). A Semi-Final and/or Final of the Contest will be staged. Winners of the Contest may be nominated by TVB to participate in international beauty contests.
- (B) TVB may in its absolute discretion produce television programmes of or relating to the Contest and distribute the same by whatever means. All rights of and in such television programmes are owned by TVB.
- (C) This Application Form can be completed by either the Contestant or the Nominator in accordance with paragraph 4 (Entry Procedure) below. If this Application Form is completed by the Contestant, it must be signed by both the Contestant and Nominator (if the Contestant is under the age of 18, it must be signed by parent or guardian on her behalf). If this Application Form is completed by the Nominator, it is required to be signed by the Nominator; the Contestant is not required to sign this Application Form.
- (D) TVB reserves the final determination in all relevant arrangements and its interpretation of the terms and conditions in this Application Form will be final.

2. ELIGIBILITY

To be eligible to participate in the Contest, the Contestant must fulfill each of the following requirements:

- (A) The Contestant is female.
- (B) The Contestant is at least 17 years of age by 1 August 2023 and has not attained 28 years of age by 29 February 2024 (by Western reckoning).
- (C) The Contestant is the holder of a valid Hong Kong identity card and passport.
- (D) The Contestant is nominated by a person who fulfills all the requirements set out under paragraph 3 below.
- (E) The Contestant is not bound by any contract which will prevent her from entering or perform the contract with TVB as referred to in paragraph 6 below.
- (F) The Contestant is not an employee of TVB or its group companies.
- (G) The Contestant has never been through any marriage ceremony either valid or invalid marriage, whether civil, religious, customary or tribal which is recognized as a marriage ceremony in any part of the world.
- (H) The Contestant has never been pregnant.

Provided always that TVB may in its absolute discretion waive and/or relax one or more of the above requirements after taking into consideration the Contestant's circumstances and background.

3. THE NOMINATOR

The Contestant must be nominated by a natural person (not company), and TVB welcomes nomination by all artistes in Hong Kong. The Nominator must fulfill each of the following requirements:

- (A) The Nominator has known the Contestant personally on the day of signing this Application Form.
- (B) The Nominator is at least 18 years of age (by Western reckoning) on the day of signing this Application Form.
- (C) The Nominator is the holder of a valid Hong Kong identity card or passport.
- (D) The Nominator will appear in person in the television programme of or relating to the Contest produced by TVB when required to do so by TVB.
- (E) Each Nominator can nominate more than one Contestant.
- The Nominator is not an employee of TVB or its group companies (artistes excluded).

4. ENTRY PROCEDURE

- (A) If this Application Form is completed by the Contestant, she must:
 - (i) fill in the "Contestant information" and sign this Application Form;
 - (ii) fill in the "Nominator information" and have the Nominator sign this Application Form;
 - (iii) fill in details of her parent or guardian (if the Contestant is under the age of 18); and $\,$
 - (iv) submit the completed Application Form together with the following attachments:
 - a. photocopy of the Contestant's Hong Kong identity card and passport; and
 b. two recent posed photographs (both taken within 3 months from the date of submission), one showing her in half length and the other in full length.
- (B) If this Application Form is completed by the Nominator, the Nominator must:
 - (i) fill in those parts marked ## in the "Contestant information", and provide other information (if available);
 - (ii) fill in the "Nominator's information" and sign this Application Form; and
 - (iii) submit the completed Application Form together with the Contestant's recent photograph(s) (taken within 3 months from the date of submission).
- (C) Completed Application Form with the aforesaid documents must be submitted to TVB on or before 5 June 2023 via one of the following methods:

5. SELECTIONS

TVB will consider all applications it receives and select from the applications some Contestants to attend the selections at the time(s) and place(s) designated by

- TVB. The selection criteria and format will be determined by TVB and the selection process may be filmed and produced as television programmes and distributed by whatever means.
- B) TVB will select some Contestants from the selections to participate in the Semi-Final and/or Final.
- (C) TVB will notify the shortlisted Contestants to attend selections. The Contestants outside Hong Kong shall make themselves available for attending selections in Hong Kong at the designated time as notified by TVB. For each Contestant being selected by TVB to participate in the Semi-Final and/or Final of the Contest, TVB shall sponsor her one round-trip air ticket expenses (economy class) from her place of residence to Hong Kong, provided that she can produce supporting documents showing her arrival in Hong Kong during the aforesaid period of selections and payment receipt of the air ticket.

6. CONTRACT

As a condition precedent to the Contestants participating in the Semi-Final and/or Final of the Contest, the Contestants must enter into separate contract with TVB.

7. ACKNOWLEDGEMENT

- (A) The Contestant hereby acknowledges and agrees that TVB may in its absolute discretion:
 - (i) request her to produce evidence of her residence;
 - (ii) accept documents of identity other than Hong Kong identity card or passport;
 - (iii) withdraw her from the selections and the Contest (as the case may be) without assigning any reasons; and
 - (iv) reschedule or cancel the selections and/or the Semi-Final and /or Final of the Contest.
- (B) The Contestant warrants that she has cleared the rights for TVB to use the photographs referred to in paragraph(s) 4(A) and/or 4(B), in all manners and format. She further acknowledges and agrees that the proprietary right of the said photographs shall be vested in TVB upon her submission of this Application Form. She shall not demand the return of the same under any circumstances. Further she shall not demand the return of the photocopies of the documents and materials referred to in paragraph(s) 4(A) and/or 4(B) except in accordance with Special Note C(i) herein.

8. WARRANTIES

(A) If this Application Form is completed by the Contestant

The Contestant warrants and undertakes that:

- (i) all information filled out in this Application Form is true and accurate;
- (ii) the photograph(s) of the Contestant are taken recently within 3 months from the date of submission;
- (iii) she is the copyright owner and owns all rights in and to the photograph(s) submitted; or she has obtained the authorization from the copyright owner of the photograph(s) submitted to grant such rights to TVB group and their business partners to enable them to exploit the photograph(s) in any and all manners without restrictions as they think fit throughout the world in perpetuity;
- (iv) the photograph(s) submitted are original work of the Contestant, and do not contain any material that is plagiarizing, defamatory or infringes the intellectual property rights, privacy rights or other rights of a third party.
- (B) If this Application Form is completed by the Nominator

The Nominator warrants and undertakes that:

- (i) all the information filled out in this Application Form is true and accurate;
- (ii) the Nominator has known the Contestant personally;
- (iii) the photograph(s) of the Contestant are taken recently within 3 months from the date of submission;
- (iv) the Nominator is the copyright owner and owns all rights in and to the photograph(s) submitted; or has obtained the authorization from the copyright owner of the photograph(s) submitted to grant such rights to TVB group and their business partners to enable them to exploit the photograph(s) in any and all manners without restrictions as they think fit throughout the world in perpetuity;
- the photograph(s) submitted are original work, and do not contain any material that is plagiarizing, defamatory or infringes the intellectual property rights, privacy rights or other rights of a third party; and
- (vi) the Contestant has noted that she has been nominated for the "Miss Hong Kong Pageant 2023", and provided contact details and recent photograph(s) to TVB, consented TVB to contact her for further discussion on relevant details.

9. LANGUAGE

This Application Form is written in both English and Chinese. The Contestant understands that the Chinese translation is for reference purpose only and in the event of conflict between the English and the Chinese versions, the English version shall prevail.

10. LAW

The terms and conditions herein contained shall be governed by and construed in accordance with the laws of Hong Kong Special Administrative Region.
